The initial Title V permit for this facility was issued on November 5, 2003. Details of the previous revisions can be found in Section X of the permit "Revision History". All proposed changes to the current permit are clearly shown in strikeout/underline format for the first public notice and double strikeout/underline format for the second public notice.
